She moved to Alberta Treasury Board and Finance in 2011 as manager in the Economics, Demography, and Public Finance branch before serving as the Deputy Chief Economist. Catherine holds a Master's degree in economics from the University of Guelph and a Bachelor of Commerce from the University of Alberta.
