Professionalism and Ethics (2018PC-02)

This may be a two-day workshop.

The Alberta Assessors' Association adopted the current Code of Conduct and Ethics as part of its pursuit of self-regulation and membership in POARA. In 2015, following considerable discussion and study of the professional standards of various organizations, the Association "borrowed" Ontario's Institute of Municipal Assessors Code of Code of Ethics and Professional Standards, rephrased portions to align with Alberta's legislative requirements and adopted the AAA Code of Conduct and Ethics and Professional Standards.

This course is the first offering of the Association's Professionalism and Ethics course based on the 2015-approved Code of Conduct and Ethics and Professional Standards. It is both a learning opportunity and a test of the material. **Senior assessors, assessor-supervisors and assessor managers are encouraged to participate but all regulated members are welcome.** Participants will be asked to interact, evaluate and provide feedback in the manner of a critical analysis the material in order for revisions or adjustments may be made, as necessary so that the course content is wholly appropriate for future delivery. The material will consider how the AAA Code of Conduct and Ethics and Professional Standards applies in the work environment and in external but related situations. Organizational culture and personal values are also considered in the context of professional ethical behaviour. The AAA acknowledges the IMA for its course and the conditions for its use by the AAA.

Worksafe III (2018PC-03)

Workplace violence is everybody's concern. Events across North America have highlighted the need for corporations to have the ability to protect their most important asset; their people. The StreetSense WorkSafe program utilizes a Reality Based IntelligenceLed approach to violence prevention and personal safety. The approach is unique in that it examines threats from both a micro and macro perspective and provides clients with increased safety and security for their employees and management as well as a flexible platform for future planning and training.

Intelligence Led violence prevention provides a "Big Picture" view of organizational vulnerability using a variety of sources to create a three hundred sixty degree picture of potential threats, outlines areas of concern and makes planning and allocation of resources more efficient.

Personal safety training including self defense as part of the equation in reducing the impact of violence in the workplace. Policies and procedures must be realistic and include provisions for training all staff on workplace violence prevention and other potential threats to their safety and security. Training increases survivability. Statistically the more people that are trained, the more that will survive workplace related incidents of violence by the skills and confidence to act proactively.

Advanced Excel for Assessors (2018PC-04)

For assessors, data is truly a double-edged sword: it is essential for doing our jobs, yet can be the worst possible beast to wrestle meaning out of in order to do our jobs.

Fundamentally, assessors need to work with data in three different ways:

- 1. Manipulate multi-source data so it can be combined
 - Text to Columns & Concatenate, Vlookup
- 2. Analyze data for meaning
 - Logic Formulae, Filters & Subtotals
- 3. Display assessment data for external consumption/education
 - Pivot Tables, Pivot Charts

Arbitrators are appointed to solve disputes under commercial contracts, in labour disputes, family and estate disputes. This allows Carol to use her strong skills in fair process and decision writing as an independent neutral adjudicator. Carol is also an instructor with the Foundation of Administrative Justice, which is a non-profit organization that provides board member training.

Michael Arnold, AMAA, Assessment Coordinator & Analyst, City of Red Deer started his assessment career with the City of Red Deer in 2006. He received his accreditation in 2011 and became the Coordinator for Residential/Multifamily assessment team in 2013.
